Project sites needed for spring wildlife monitoring project

The California Department of Fish and Wildlife's (CDFW) Nongame Wildlife Program is seeking interested landowners to volunteer in a large-scale wildlife monitoring effort. This project will use motion-activated infrared cameras and acoustic recorders to collect data that will provide a better understanding of wildlife habitat use on cropland, rangeland, orchards and wetlands. Participants will

work with CDFW staff and research technicians from CSU Fresno to identify specific study sites on their property, and data will be collected during a four-week period between March and June 2016. All data published will be generalized to the level of a 5-km area around the study sites, and no details regarding individual properties or landowners will be published. Funding opportunities for farmers, ranchers

The Agricultural Act of 2014, commonly known as the Farm Bill, provides funding to farmers and ranchers who want to implement conservation projects on their farms and ranches through the Environmental Quality Incentives Program (EQIP). Participation is voluntary and projects are chosen based on the benefit to local natural resources and on available funds.

There are still opportunities for producers to participate in the 2016 program. Applications are being accepted continuously, and there are four "batching periods" remaining this year, in which new projects will be funded.

"Now is the time to begin your conservation plan and apply for funding. There are so many oppor-

tunities available to conservation-minded producers," says District Conservationist Wendy Rash. "We have helped with technical and financial assistance on projects ranging from irrigation systems, to cover crops, to fencing and watering facilities on rangelands, to tailwater ponds and wildlife habitat."
